Cloud Propeller, Inc. (“Cloud Propeller”) respects the privacy of its Users. The purpose of this Privacy Policy is to explain the types of information Cloud Propeller obtains about Users, how the information is obtained, how it is used, how it may be disclosed to others and how Users may restrict its use or disclosure. Cloud Propeller reserves the right to revise this privacy policy, while also revising its practices regarding the collection or use of other information obtained from Users in the future.

Personally Identifiable Information

The only personally identifiable information Cloud Propeller obtains about individual Users through Cloud Propeller services is information supplied voluntarily by Users. Users may provide Cloud Propeller with name, address, telephone number, billing information such as credit or debit card numbers or bank account numbers, email address, domain name or URL or other information which may be defined as personally identifiable information under state or federal law that Cloud Propeller may use for its own business purposes. Cloud Propeller may also keep records of which Cloud Propeller services a User has purchased or considered and may draw inferences about information collected to determine a User’s preferences or characteristics. At this point in time Cloud Propeller does not share such information with its partners.

Non-Personally Identifiable Information

Cloud Propeller does not collect non-personally identifiable generic information about Users.

IP Addresses

An IP address is a number that is automatically assigned to Users’ computers when using the Internet. Web site servers can automatically identify individual computers and their locations by their IP address. Cloud Propeller collects IP addresses for the purposes of system administration and to report aggregate information. Cloud Propeller does not intentionally link IP addresses to any personally identifiable information.

Cookies

Cookies are pieces of information that are used for record-keeping purposes. Cookies allow Cloud Propeller to save certain information about Users, such as a password or individual preferences, in order to facilitate and enhance Users’ future activities with Cloud Propeller services. Cloud Propeller will not use cookies to retrieve information from the User’s computer that was not originally sent in a cookie. Except as otherwise provided in this privacy policy,

Cloud Propeller shall not use information transferred through cookies for any promotional or marketing purposes and shall not share that information with any third parties for any reason.

Computer Settings

Settings, technical and other information from the User’s computer, such as the User’s operating system, browser version, connectivity, various communication parameters and other information related to the operation and interaction of Cloud Propeller services may be collected by Cloud Propeller. Except as otherwise provided in this privacy policy, Cloud Propeller will use such information solely in order to provide technically appropriate formatting of information provided by Cloud Propeller and access to Cloud Propeller services. The collection of this information will not include any personally identifiable information about Users.

How Information is Collected

Cloud Propeller collects information directly from its Users including through its websites, any product or service registration, interactions with customer service, interactions at trade shows or conferences, IP addresses, cookies, and other similar means.

Disclosure Pursuant to Legal Process

Cloud Propeller shall, pursuant to applicable law, regulation or legal process, such as a search warrant, subpoena or court order, allow access to all available and relevant User information in order to comply with such process and protect Cloud Propeller’s or User’s rights and property. Cloud Propeller may also allow access to User information in emergencies where physical safety may be at risk.

Transfer of Business Assets

Cloud Propeller considers its User information to be one of its business assets. Should Cloud Propeller sell or transfer all or substantially all its business assets to another entity, User information will be one of those transferred business assets.

Third-party Websites

Cloud Propeller is not responsible for the content or the privacy practices of third-party Web sites, including Web sites reached through Cloud Propeller Services. Other Web sites may have different privacy policies or no policy. Users should review the privacy policies of any Web site before providing personal information.
